# TERMS OF REFERENCE FOR THE INDEPENDENT REVIEW OF THE N.Z. HARNESS RACING RATING SYSTEM FOR HANDICAPPING 2023

## Purpose of the review:

To conduct a thorough review of the current Handicapping system with the view of improving horse utilisation by;

- Identify the strengths and weaknesses of the system and whether it is being used to its potential or not.
- Find solutions to the weaknesses to make the system more robust and fit for purpose.
- To give confidence to our participants that the system is fair.

## **Outcome required:**

To achieve the fairest and most equitable method of handicapping to ensure competitive racing throughout the country for all horses.

HRNZ has appointed an independent working group to review the Handicapping system who will present the group's findings to the Board. The Board has requested representation from each HRNZ region to be on the Working Group.
