



Alexandra Park presents two new Winter Racing Series for horses both from the South and those that are here already in the North.

**Southern Sourced Maiden**  
**Winter Futurity Series - Stake \$30,000**

1. The stake for the Final will be \$30,000.
2. For 3yo and Older Pacers who are rated as (MR) Non-Winners for Handicapping Purposes after the completion of racing on 31 March 2021. To be eligible to compete in the futurity series a horse must have had a minimum of two official race starts in the South Island up to and including 30th April 2021 and for whom the appropriate enrolment fee for this race (\$200) was paid by the 3<sup>rd</sup> May 2021.
3. A horse must compete in three official races run by the Auckland TC at Alexandra Park from 7 May 2021 and up to and including 16 July 2021 to be eligible to compete in the Futurity Final on 30 July. These three races include any MR (Non-Winner) or R (Race-Winner) races.
4. The race dates of these meetings are 7, 13, 21 & 28 May, 4 & 18 June and 2, 16 & 30 July. The minimum stake for a MR race at Alexandra Park is \$12,000.00.
5. Points for places in the final can only be accumulated at Auckland Trotting Club meetings and will be awarded as follows: 5 points for 1<sup>st</sup> placing, 3 points for a 2<sup>nd</sup> placing and 1 point for a 3<sup>rd</sup> placing.
6. If at acceptance time for the final a tie for points exists, a count back system will be used to determine preference based on which horse has started the most at ATC meetings between 7 May 2021 and 16 July 2021. If a tie still exists, club discretion will apply.
7. Any horse eliminated or balloted out of a race or accepted into a race that is abandoned will be accorded a recorded start towards satisfying the eligibility clause above.
8. The Final will be run on 30 July 2021 and will be a 2200m Mobile with a Preferential Draw Based on Winning Stakes accumulated in the series using the track grid. The field will be limited to 13 starters with no emergencies.
9. Any horse selected to start in the Futurity Final on 30 July 2021 will be ineligible to start in any other race on that programme.
10. In the event of insufficient entries as at the 3<sup>rd</sup> May 2021 the club reserves the right to combine both the North Island and South Island series.
11. No late nomination provision applies.
12. A horse may only nominate for one of these futurity races.
13. The club reserves the right to alter either of the above series conditions should it be deemed necessary.

**ATC Winter Futurity**  
**Stake - \$30,000**

1. The stake for the Final will be \$30,000.
2. To be eligible to compete you will need to a 3yo and Older Pacer who were either unqualified or were rated as (MR) Non-Winners for Handicapping Purposes after the completion of racing on 31st March 2021 and for whom the appropriate enrolment fee for this race (\$200) was paid by the 3<sup>rd</sup> May 2021.
3. A horse must compete in three official races run by the Auckland TC at Alexandra Park from 7 May 2021 and up to and including 16 July 2021 to be eligible to compete in the Futurity Final on 30 July. These three races include any MR (Non-Winner) or R (Race-Winner) races.
4. The race dates of these meetings are 7, 13, 21 & 28 May, 4 & 18 June and 2, 16 & 30 July. The minimum stake for a MR race at Alexandra Park is \$12,000.00.
5. Points for places in the final can only be accumulated at Auckland Trotting Club meetings and will be awarded as follows: 5 points for 1<sup>st</sup> placing, 3 points for a 2nd placing and 1 point for a 3<sup>rd</sup> placing.
6. Any horse eliminated or balloted out of a race or accepted into a race that is abandoned will be accorded a recorded start towards satisfying the eligibility clause above.
7. If at acceptance time for the final a tie for points exists, a count back system will be used to determine preference based on which horse has started the most at ATC meetings between 7 May 2021 and 16 July 2021. If a tie still exists, club discretion will apply.
8. The Final will be run on 30 July 2021 and will be a 2200m Mobile with a Preferential Draw Based on Winning Stakes using the track grid. The field will be limited to 13 starters with no emergencies.
9. Any horse selected to start in the Futurity Final on 30 July 2021 will be ineligible to start in any other race on that programme.
10. In the event of insufficient entries as at the 3<sup>rd</sup> May 2021 the club reserves the right to combine both the North Island and South Island series.
11. No late nomination provision applies.
12. A horse may only nominate for one of these futurity races subject to clause 7.
13. The club reserves the right to alter either of the above series conditions should it be deemed necessary.
