1. For each Silk Road Winter Series, three-year-old and older Fillies and/or Mares must be eligible at the close of Nominations for each heat Nominated for.
2. Nominations must be made with the HRNZ Bureau in the normal manner for each race of these series.
3. The conditions for each individual series are stated above, within each series table.
4. Horses must have competed in a heat to be eligible to contest a final or been balloted out or eliminated from a heat that was run. Also, eligible are horses that accepted for a heat that was abandoned.
5. The first three placegetters in each heat shall be automatic qualifiers for finals, if nominated, except for Non-Win only heats, where only the winner will automatically qualify and be eligible to contest the Final.
6. The remainder of Final fields will be selected by the HRNZ Bureau with preference given to overall form in heats.
7. Horses that win a Heat & a Final will receive a Rating Penalty Free win in the Final.
8. Fillies and/or Mares that win or start in a heat and subsequently ascend to a Rating higher than that prescribed for heats will not be eligible to compete in further heats but remain eligible for that Final.
9. Any horse winning two heats of a series will be ineligible to contest any further heats in that series.
10. Fields for all heats in these series will be selected on Ratings (highest to lowest), then form.
11. Barrier Draw systems and Handicaps for Heats and Finals of all series are detailed in individual series tables. Any races programmes as Preferential Barrier Draws will be sequential.
12. All races in these series are restricted to race winners only, except for designated Non-Win qualifying races, where the winner will gain eligibility and automatic entry into the series Final.
13. A minimum of six acceptors will be required for a heat or final to proceed.
14. In the event of extraordinary entries for any given heat, the HRNZ Bureau reserves the right to run an additional heat(s).
15. In the event any horse eligible to contest a heat or final ascends to a Rating above the prescribed maximum for a series such horse(s) will remain eligible for the Final. In the case of a Handicap series, the affected horse(s) will be handicapped 10m further than the current prescribed back mark.
16. HRNZ reserves the right to alter or amend conditions of these series in the event of circumstantial change.
17. Any matters arising from this series not covered by these conditions or the Rules & Regulations of HRNZ will be determined by the CEO or duly appointed representative of HRNZ.
