## NAME FOR THE RACE COMPETITION-TERMS AND CONDITIONS

- 1. All Entrants ("Entrants") who participate in this Harness Racing New Zealand (HRNZ) Name For The Race Competition (the "Competition") are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and HRNZ takes no responsibility for such entries.
- 2. The Competition will commence at 6:00PM October 10, 2024, with entries for stage One (1) closing at 4:00PM, October 17, and Stage Two (2) People's Vote closing at 5:00PM October 25, 2024 (the "Competition Period").
- 3. Eligible Entrants entry is open to all fans, eighteen years old and over, of New Zealand's most exciting racing code harness racing.
  - 4. An Entrant may submit one (1) Competition Entry only.
  - 5. For an Entry to be valid, an Entrant's submitted name must not be a duplicate of an earlier entry.
  - 6. Names for the Race that are submitted that are defamatory, abusive, obscene, unlawful, racist, discriminatory, or otherwise offensive will not be valid entries.
- 7. After the completion of Stage 1 of the Competition Period, at 6:00PM October 10, 2024, HRNZ shall review the submitted entries and determine the three (3) names to go forward to Stage 2, a public vote to determine the Name For The Race winner
- 8. The public vote will close at 5.00PM October 25, 2024 The name that has received the most votes will be declared the Name For The Race name on Monday 21st October.
- 12. The Entrant who submitted the winning name in Stage 1 will be declared the Prize Winner. If more than one Entrant submitted the winning name, HRNZ will conduct a random draw of one Entrant from all Entrants who submitted the winning name. The drawn Entrant will be declared the Prize Winner.
- 13. The Prize Winner will win: Two tickets to the Silks Lounge (including food and drink) or six tickets to the ZM On the Green for the Show Day Twilight races (Friday, November 15) and the chance to be on the stage trackside at Addington Raceway on Derby day (December 6) to watch the race and presentation and then attend the Breckon Winning Owners' bar with the winning connections.
- 14. If the Prize (or any part of the Prize) is unavailable for any reason, HRNZ, in its sole discretion, reserves the right to substitute the Prize (or part of the Prize) with a prize to the equal monetary value. The Prize, or any unused portion of the Prize, cannot be exchanged for cash or other products or services, or otherwise transferred or modified.
  - 15. HRNZ will contact the Prize Winner via email.
  - 17. All costs not included in the Prize are the sole responsibility of the Prize Winner.

Except for any liability that cannot be excluded by law, HRNZ and any person in connection with this Competition are not liable for any direct, indirect, special or consequential loss or damage whatsoever suffered or personal injury suffered or sustained in connection with: (a) Registration for or participation in this Competition; (b) The use (or non-use) of the Prize; and (c) The administration of this Competition.
